

Notice of temporary road closure, Wardington Road

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. What are we doing?

As the project progresses, it is necessary to carry out essential Ground Investigation Surveys. These surveys help us learn more about the land we will be working on.

Our surveys will be carried out over four days at the junction of Wardington Road with Welsh Road, near Edgcote. We are required to close a section of Wardington Road for the duration of the works.

For reasons of safety, there will also be temporary traffic lights at the junction of Wardington Road with Welsh Road, near Trafford Bridge. This is for the safety of road users and our staff because the Trafford Bridge is very narrow.

When will these works take place?

A section of Wardington Road will be closed on the following week days: Thursday 4 November to Friday 5 November and Monday 8 November to Tuesday 9 November. To reduce disruption as much as possible, we do not intend to close this road over the weekend and it will only be introduced off peak from 9.00am to 4.00pm, with a local diversion in place.

Temporary traffic management will also be in place at the junction of Wardington Road with Welsh Road. We will work to open the roads to reduce disruption as soon as possible.
